

**DETERMINATION AND FINDINGS
FOR
SOLE SOURCE PROCUREMENT**

1. **Authorization**ⁱ

2. **Minimum Need:**

The Office of the People’s Counsel requests the services of DataNet Systems Corporation to host the website for the Office of the People’s Counsel.

3. **Estimated Fair and Reasonable Price:**

\$6,000.00

4. **Facts That Justify a Sole Source Procurement:**

- A. The Office of the People's Counsel “OPC” is an independent agency of the District of Columbia government. By law, it is the advocate for consumers of natural gas, electric and telephone services in the District. District of Columbia law designates the Office as a party to all utility-related proceedings before the Public Service Commission. The Office also represents the interests of District ratepayers before federal regulatory agencies. The Office is authorized to investigate the operation and valuation of utility companies independently of any pending proceedings.

- B. DataNet Systems Corporation is a 100% minority-owned technical services company with headquarters in Washington, DC. DataNet was established in 1986 and enjoys a 25-year tradition of providing quality technical and management solutions for different commercial and government web-based, application, systems and software integration for communications and networking applications. DataNet Systems designed OPC’s previous and current web page and is familiar with its current configuration. DataNet is currently providing website development, programming support and hosting services to manage high security sites such as the Air National Guard. DataNet has also provided key Technical and Project Management support in building the DC WAN Network

Operations Center (DC NOC) in the Wilson Building for the Office of Chief Technology Officer. DataNet also provides unique Web development and hosting services for key independent DC Government agencies including DC BOEE, the DC Public Service Commission, the Office of Campaign Finance.

C. It is for the reasons outlined herein that it is recommended that a sole source contract be awarded to DataNet Systems Corporation.

ⁱ Procurement authority is vested in the Commission pursuant to § 13 (c) (2) of the Residential Real Property Seller Disclosure, Funeral Service Date Chang, and Public Service Commission Independent Procurement authority Act of 1998 (D.C. Law 12-263). The Commission is statutorily exempt from the D.C. procurement rules as set forth in D.C. Official Code §1-1181 et seq.

DC Law: 34-804, hereby established within the Public Service Commission of the District of Columbia, has established by DC Law: 34-801, an office to be known as the “Office of the People’s Counsel”. The office shall be a party, as of right, in any investigation, valuation, revaluation, or proceeding of any by nature by the Public Service Commission of or concerning a public utility operating in the District of Columbia.
