

**DETERMINATION AND FINDINGS

SOLE SOURCE PROCUREMENT**

1. **Authorization**<sup>i</sup>

2. **Minimum Need:**

The Office of the People’s Counsel requests the services of Synapse Economics, Inc. to provide research and editing services in connection with analyzing distributed solar capacity, the value of solar photovoltaics and rate design options for sustainably supporting distributed solar in the District for the Office of the People’s Counsel.

3. **Estimated Fair and Reasonable Price:**

\$15,000

4. **Facts That Justify a Sole Source Procurement:**

- A. The Office of the People's Counsel “OPC” is an independent agency of the District of Columbia government. By law, it is the advocate for consumers of natural gas, electric and telephone services in the District. District of Columbia law designates the Office as a party to all utility-related proceedings before the Public Service Commission. The Office also represents the interests of District ratepayers before federal regulatory agencies. The Office is authorized to investigate the operation and valuation of utility companies independently of any pending proceedings.
- B. Synapse Economics, Inc. is a research and consulting firm specializing in energy, economic, and environmental topics.
- C. Synapse Economics, Inc. has proved technical, economic, research and writing support to OPC in connection with analyzing distributed solar capacity, the value of solar photovoltaics and rate design options for sustainably supporting distributed solar in the District. Synapse Economics, Inc. is familiar with OPC’s research and editing processes and knowledgeable of past research outputs.

D. It is for the reasons outlined herein that it is recommended that a sole source contract be awarded to Synapse Economics, Inc.

<sup>i</sup> Procurement authority is vested in the Commission pursuant to § 13 (c) (2) of the Residential Real Property Seller Disclosure, Funeral Service Date Chang, and Public Service Commission Independent Procurement authority Act of 1998 (D.C. Law 12-263). The Commission is statutorily exempt from the D.C. procurement rules as set forth in D.C. Official Code §1-1181 et seq.

DC Law: 34-804, herby established within the Public Service Commission of the District of Columbia, has established by DC Law: 34-801, an office to be known as the “Office of the People’s Counsel”. The office shall be a party, as of right, in any investigation, valuation, revaluation, or proceeding of any by nature by the Public Service Commission of or concerning a public utility operating in the District of Columbia.
