

**DETERMINATION AND FINDINGS  
FOR  
SOLE SOURCE PROCUREMENT**

1. **Authorization**<sup>i</sup>

2. **Minimum Need:**

The Office of the People’s Counsel requests the services of Walls & Associates, Inc. to provide publication services for the Office of the People’s Counsel in connection with OPC’s senior outreach report.

3. **Estimated Fair and Reasonable Price:**

\$5,000

4. **Facts That Justify a Sole Source Procurement:**

- A. The Office of the People's Counsel “OPC” is an independent agency of the District of Columbia government. By law, it is the advocate for consumers of natural gas, electric and telephone services in the District. District of Columbia law designates the Office as a party to all utility-related proceedings before the Public Service Commission. The Office also represents the interests of District ratepayers before federal regulatory agencies. The Office is authorized to investigate the operation and valuation of utility companies independently of any pending proceedings.
- B. Walls & Associates will collaborate with agency staff to produce and publish an OPC Senior Outreach Report.
- C. The OPC Senior Outreach Report must be produced in a limited time frame. Walls & Associates has experience working closely with agency staff and is acutely aware of the Office’s publication processes.
- D. It is for the reasons outlined herein that it is recommended that a sole source contract be awarded to DataNet Systems Corporation.

Law 12-263). The Commission is statutorily exempt from the D.C. procurement rules as set forth in D.C. Official Code §1-1181 et seq.

DC Law: 34-804, herby established within the Public Service Commission of the District of Columbia, has established by DC Law: 34-801, an office to be known as the “Office of the People’s Counsel”. The office shall be a party, as of right, in any investigation, valuation, revaluation, or proceeding of any by nature by the Public Service Commission of or concerning a public utility operating in the District of Columbia.
